Council Votes

New Water Line

To Construct

A new two-inch water line will be run into the black neighborhood in Malone, the Town Council decided at its regular meeting on Tuesday evening, Feb. 22.

The new water line has been made necessary by the construction of several new houses in the area.

Garbage Complaints

The Town Council also discussed numerous complaints it has received about sloppy garbage pick-up service. Mayor Robert J. Watford was asked to see if the present garbage pick-up service can be operated cleanly and efficiently.

If it cannot, the councilmen indicated that some other type of service may be tried.

Lights Policy

Because the council had been asked to have street lights erected on private property, the policy for establishing lights was torated. The town will and maintain street lights only on public streets and where the lights will serve a number of houses.

New Budget

The council reviewed its tentative budget for 1972. Anticipated income from cigarette and other state taxes is \$18,000. Anticipated expenses which are paid from this fund--salary of the town nightwatchman, street lighting and maintenance, legal fees, garbage pick-up service, insurance, city hall and fire truck maintenance--total \$16,237.

Anticipated income from the water system is \$10,725. Anticipated expenses to be paid from the water account--cost of maintaining water system, water pipes, supplies and labor to

install water pipes--is \$16,120. Anticipated income from the new eighth-cent gas tax is \$1,800. No expenses have been budgeted for the gas tax account

Hickory Grove Celebrates Willie Stephens Day

A large congregation of friends and relatives gathered Sunday, Feb. 20, at Hickory Grove Free Will Baptist Church to honor John William Dallas Stephens on "Willie Stephens

Mr. Stephens was presented with a boutonniere, a huge birthday cake and a fountain pen mounted on a marble base with his initials inscribed in gold.

The church which honored him is younger than he is, having been organized when he was one and one-half years old. His 94th birthday was Feb. 23.

For 69 of his years-since 1903--Mr. Stephens has served as clerk of the church, meticulously keening its records in his fine handwriting.

Mr. Stephens has always lived in the Hickory Grove area. He attended school in a schoolhouse located near the church. Later, he attended two terms of school at Bascom.


Mr. Stephens took examinations and qualified to be a teacher in 1898. However, his teaching career lasted exactly one year. "I didn't like it," Mr. Stephens said. "I liked farming."

"I guess you could say I had a two-horse farm," Mr. Stephens said, smiling. "We didn't have tractors when I was farming. However, I eventually graduated to a three-horse farm.

Mr. Stephens now lives near Bascom with his only daughter and son-in-law, Mr. and Mrs.

George Hatcher (Mildred), almost within sight of the house where he and his wife reared their two children. Mrs. Stephens, the former Lillian Jordan, died in 1961. Their only son, James, died in World War II.

County Commission Meeting

Delegation Complains About Unpaved Road

County Commissioners was confronted by a large and unhappy delegation of taxpayers during its meeting on Tuesday morning, Feb. 22.

The delegation was composed of people who live along 10 miles of an unpaved road north of Four Points, between Grand Ridge and Sneads.

Lamar Creel, pastor of El Bethel Assembly of God Church and spokesman for the group, said the commission has promised to pave the nearly-impassable road for 12 years.

Road Planned

After the delegation left, the commissioners discovered that the problem had already been solved. A resolution from the State Department of Transportation, which the commissioners immediately signed, lists the road as the top priority item in next year's secondary road budget. It will probably be paved in about a

The delegation was particularly angry because the commissioners had agreed two weeks ago to have slightly over a mile of their road paved, but also to pave six-tenths of a mile on the Christian School Road in Marianna.

The delegation demanded to know how the Christian School Road got ahead of its road on the list of priorities. Commissioners explained that the decision to pave was made after a traffic count revealed

The Jackson County Board of that 480 cars travel the Christian School Road daily.

Grand Ridge Prisoners

The Grand Ridge Town Council appeared at the meeting to request that its town be allowed to place prisoners in the county jail.

"Our jail is going to be condemned in July," Grand Ridge Mayor Raino Watts said, "and we'll have no place to keep prisoners until a new jail is built."

The commissioners indicated that the proposal will be approved after their attorney has investigated the legality of the move and the cost per prisoner to be charged.

Oil Prospectors

Two representatives from the Southern Natural Gas Company, Dewitt Cribbs and George Muns, were given permission to test for oil and natural gas along county road rights-of-way with a Viber-Size.

The men explained that they are not drilling for oil, but testing for typical "oil structures" in the county's typography.

Cribbs told the board that the prospect for oil discovery in the county is "looking mighty good." His company is also running tests in Washington and Holmes counties and may test in Gadsden County as well, Cribbs said.

Radio Equipment

The Commission accepted new radio equipment worth \$61,933 for the county sheriff's department and municipal police departments in the county. The equipment was a federal grant and cost the county nothing.

Public Meeting

The board was advised by the Game and Fresh Water Fish Commission that a public meeting will be held on Wednesday, March 1, at 7 p.m. in the Circuit Courtroom to consider hunting season dates and other rules and regulations pertaining to hunting and fishing.

In other business the board: Appointed Commissioner Fred Williams as its representative to the Tri-Rivers Development Association;

Gave Commissioner Neal Carter permission to purchase enough hot mix to patch one mile of road at Cloverdale Farms:

Agreed to close its cement pipe plant at the County Road Camp on March 1 and to begin using galvanized pipe on county projects;

Decided to advertise for bids on 1,000 road and bridge reflectors.

The speaker was Dr. Mack Craig, dean of students at David Lipscomb College in Nashville, Tenn. Dr. Craig is a specialist in the history of the Old South.

In addition to members of the commission, a number of special guests participated in the meeting which was held at Great Oaks, the restored ante-bellum home of Mr. and Mrs. Claude Reese in Greenwood.

Dr. Craig said that The been completely restored in every detail. All of its original furnishings have been recovered.

Jackson built the mansion outside Nashville, Dr. Craig said, as a setting for his wife. Rachel was ostracized by Nashville society because she married Jackson, mistakenly thinking that her first husband had divorced her.

Although Rachel subsequently divorced her first husband and remarried Jackson, the incident created a scandal from which the couple never escaped. Rachel was condemmed as an adulteress by many people for the rest of her life.

Claude Reese, chairman of the historical commission, announced that he will purchase and restore another historic house, located near Great Oaks. in Greenwood. The house was originally built by E. T. C. Dickinson and his wife, Elizabeth Bryan Dickinson, probably in the 1870's.

On display at the meeting was a page from an 1870 account book kept by a Jackson County merchant, James Baker. It had been decoupaged onto a wall plaque by Mrs. Sara Harris of Marianna, Baker's great granddaughter.

Reese also announced that a speaker's bureau has been organized by the commission to familiarize Jackson Countians with their history.




