The interior and furnishings of the house have been lovingly preserved. Even its yard, in which Union and Confederate forces fought during the Battle of Mariana, retains its Old South character.

Childs Urges More Local Fund Control

Robert E. Childs, Jackson County superintendent of schools, urged members of the Malone Parent-Teacher Association at a meeting on Tuesday night to tell their legislators to have the state "turn loose the purse strings of Jackson County schools."

Childs outlined the manner in which the State Department of Education, through the Minimum Foundation Program, dictates to local schools how practically all their funds can be spent.

Of the seven mills of tax levied for schools in Jackson County, six mills must be turned over to the state, Childs said. "That leaves us to control one mill, or about \$100,000."

However, the county receives far more from the state than it gives, Childs said. But the money is so controlled at the state level that county superintendents and school boards have virtually no voice in how the money will be spent

"Before we can spend a dime," the superintendent said, "we have to write a book on it for the state to approve."

Through the legislature, Childs said, parents can demand that the state release money to the school systems. "We should raise up in arms," he said, "and tell the legislature that we are

Historic Homes On Tour Reflect Bygone Days of Jackson County

Four historic homes in Jackson County will be on display Saturday and Sunday, April 8-9, from 1 to 5 p.m. each day

Tickets for the tour of homes will be \$3. Any one of the homes may be toured for \$1.

The tour will begin at the Marianna Woman's Club where a large display of Jackson County memorabilia has been assembled.

The tour includes the McKinnon home, the West home aand the Ely-Criglar mansion in Marianna, and Great Oaks, the Claude Reese home in Greenwood.

Only Great Oaks has ever been opened to the public before and that was in 1966 after its restoration was completed. The other homes have not been restored. Instead, they have been preserved by the families that presently live in them

The Ely-Criglar mansion, located on West Lafayette Street, is the oldest home that will be displayed. It was built in 1840, five years before Florida became a state, by Francis R. Ely, a prominent Marianna merchant. The house was acquired by the Joseph M. Criglar family in 1900.

Brick used in the Ely-Criglar mansion is of native material and was made on the site. The outside woodwork was shipped from New York by boat to Apalachicola. Two wooden wings that originally flanked the

house on either side have been removed. The west wing now forms a separate dwelling at 108 Russ Street. The interior contains its original pine flooring, plaster, and walnut cornices, its original hall light and handmade front door with brass hardware.

The James McKinnon home was built in the 1850's by James Baker, whose daughter married W.H. Milton, a Confederate major and son of Florida's Civil War governor. The house is located across the street from St. Luke's Episcopal Church in whose yard the Battle of Marianna was fought.

The house was purchased in the 1890's by Judge James C. McKinnon whose descendants still live there. It exists today much as it did in the 1850's. The kitchen, which once stood a distance behind the house in case of fire, has been moved and attached to the house. Bathrooms and gas heating have been installed but the McKinnon family has made every effort to preserve both the architecture and the period furnishings.

The West home, located on Putnam Street, was built by John Davis in the 1840's for his daughter who married Dr. Theophilus West, a Florida senator. When she died, Dr. West married Miss Louise Slade of Columbus, Ga., and her personality and tastes are indelibly stamped on the house. Many of the furnishings and

objects in the house are from her family's home, St. Elmo, in Columbus, Ga.

While the downstairs of the West house is historically impressive, the upstairs will undoubtedly be one of the main attractions of the tour. The rooms upstairs contain a veritable trove of treasures and curios which have been collected by Slade West during a lift-time of extensive travels abroad.

West's collection includes a shrunken head from the Amazon, a gold sword set with diamonds and other jewels, gold that he mined in Alaska and rocks that he recently brought from Siberia.

Great Oaks was built by Hamilton Bryan in 1860 on the 5,000 acre Bryan plantation. In 1960, it was acquired by the Reese family who undertook a

five-year project that has restored the classic mansion to its original granduer both outside and in. It is largely furnished in European antiques. Tickets for the tour will go on

sale April 1: in Mariana, at Turner's, Citizen's Bank, First Bank and in the County Clerk's Office at the Courthouse; in Malone, at Sawyer's Miscellany; in Graceville, at Cash Drug Store; in Cottondale, at Hinton's IGA.

Tickets also may be ordered from Mrs. Richard Hand, 412 Second Avenue, Marianna, or may be bought on the tour days at the Woman's Club.

Commissioners Ponder Permits For Building

The Jackson County Board of Commissioners has decided to study the feasibility of requiring building permits for new construction within the county.

During its regular meeting on Tuesday morning, March 28, the board also discussed the feasibility of offering a local license test for building contractors so that they will not have to travel to Tampa to take the test offered by the State of Florida.

The commissioners gave Wilson Neal, county Veterans Administration officer, permission to close his office for a week, May 1-6, so that he and another employee may attend a training school.

Kenneth Wester, county civil defense officer, appeared at the meeting to ask commissioners to grant an old radio base, formerly used by the sheriff's department, to civil defense, so that it can be set up in the basement of the courthouse


